  Pam Lowry welcomed meeting participants

- Income Shares Outreach Irene Curran

The group has met and is working on a plan. The group is still waiting to receive needed information. They are planning a presentation for General Assembly legislative staff in regards to income shares. It is too early to set a date and time to do the presentation in Springfield.

• Error in the 3<sup>rd</sup> Quarter 2010 Quarterly Statistics – Pam Lowry

The 3<sup>rd</sup> quarter 2010 stats reflected an interface error that was corrected in the following month. The document has been annotated to reflect that. In regards to the case load numbers, there is a lot of research being done. The fluctuation in the Illinois caseload is also seen in the national caseload statistics. This may be the result of successful campaigns to reduce the teen birth rate. DCSS found that international cases were not being counted on the OCSE157 and added them, but there are less than 1,000 international cases in Illinois at this time. DCSS will continue to review the OCSE157 report.

• Cost Efficiency of Income Shares with Standardized Net as a Basis for Income – Norris Stevenson The data has been gathered but not yet fully analyzed. Norris and Pam will analyzed and report in October.
