# UPDATE ON CCBHC DEMONSTRATION EFFORTS

## HFS System Design

- HFS is working on provider enrollment and claiming buildout.

## Cost Reporting and PPS Design

- Cost reporting documentation was received from providers at the end of 2023.
- Reporting documents are being used to draft PPS rates for each provider.

## Certification Process

- Certification documentation were due from providers at the end of 2023.
- OMI Certification team is completing desk reviews and will begin on-site reviews by mid-February.
