- **Legislation – Richard Zuckerman and Bryan Tribble**
 - House Bill 3301-Initiative of the Office of the Attorney General
 - Passed the House and is now in the Senate.
 - From a child support perspective this Bill requires private contractors or gig economy workers be reported by their Payor of Income.
 - Happening in many states currently.
 - Will allow us to identify those that are working vs. those that are unemployed.

 - The 4 subcommittees are:
 - Imputation of Income
 - Incarcerated Obligor
