### Illinois Department of Healthcare and Family Services Public Education Subcommittee Meeting February 12, 2015.

### 1. Introductions

Kathy Chan, CCHHS, chaired the meeting. Attendees in Chicago and Springfield introduced themselves.

### 2. Review of Minutes

Margaret Stapleton made a motion to approve the minutes from the meeting held on December 12<sup>th</sup>, and it was seconded by John Jansa. The minutes were approved by a vote of nine in favor and zero opposed.

### 3. A guide for Applicants & Clients Receiving Health Care Coverage from HFS

Mariah Balaban discussed a project with the Subcommittee that involves the development of a consumer guide for clients who have applied for medical coverage in Illinois. The guide would be written in very general terms and include an overview of the medical programs and the basic services offered. She indicated the goal would be to provide all the basics with regard to introducing people to the system, from the time they apply for coverage through what happens as they are waiting for eligibility determination and accessing care, as well as how to stay enrolled. The guide would include topics such as how a client can renew benefits and how to report changes, in addition to providing answers to a list of the most frequently asked questions. A section including the most useful terms and acronyms would also be provided. Consumers would be informed about how to apply in three different ways: online, in-person at the FCRCs, and by mail. A list of resources, such as partner agencies and phone numbers, as well web addresses, would also be provided.

Members of the committee were enthusiastic about making this resource available for clients, commenting that this is an ambitious project. Ms. Balaban said the target for completion of this project would be June of 2015. She asked for committee members to provide feedback and to send any additional suggestions by the end of February to: <u>Mariah.Balaban@illinois.gov</u>

### 4. ACA Health Care Reform Updates

### **ABE Usability Improvement Webinar**

Lauren Polite stated that the usability team continues making progress with improvement to the ABE web site. She observed that the first wave of changes was implemented on December 17<sup>th</sup>. It included enhancements to the Frequently Asked Questions section, as well as an added segment summarizing "What to Expect Next," which appears after a client has submitted an application. The second release, which is expected to be made available in March, will include enhancements to increase readability, focusing on language and the streamlining of the application process.

In response to a request submitted by the committee during the last meeting, HFS is currently working in collaboration with EverThrive Illinois to host a webinar. This webinar will share information about the improvements accomplished in the first two releases. The session will provide an overview of recent enhancements to the ABE website, as well as new functionality which is expected to be available in the fall of 2015. This will be the first of a series of webinars intended to inform agency partners about the latest developments improving the ABE website, such as "Manage My Case" and "Renew My Case" functionalities. The webinar is scheduled for April 9<sup>th</sup> and is titled "Starting Strong for Community Health." An invitation and more details regarding how to register to attend the webinar will be forthcoming.

### **Application Process Status**

Jacqui Ellinger reported that open enrollment for individuals seeking health coverage through The Marketplace ended on February 15<sup>th</sup>, however, applicants who waited in line at the call center or experienced technical problems will be able to sign-up until February 22<sup>nd</sup> through a special enrollment period. She stated that, in spite of the increase in traffic, the ABE website did not experience any disruptions. She added that the state has a huge volume of applications coming from healthcare.gov and that, currently, state case workers are in the process of sorting through them.

Ms. Ellinger indicated that one of the highlights of this second year of open enrollment which is worth noting is that HFS and DHS case workers are getting more experienced and are becoming better able to more rapidly processes applications, which is helping the process take place more smoothly.

### Integrated Eligibility System (IES) Phase Two Update

Jacqui Ellinger led the discussion. She indicated that the Department is currently under pressure to develop Phase Two of the Integrated Eligibility System. DHS and HFS staff members continue working in partnership with Deloitte Consultants to review thousands of case scenarios in order to ensure that IES is able to support the processing of these cases as scheduled so that the system can be fully put in place. The committee asked if there would be any disruptions that could interfere with phase two of IES due to the proposed budget cuts that have recently been announced by Governor Rauner. Ms. Ellinger replied that the IES project will not be affected.

## 5. Illinois Medical Redetermination Project (IMRP) Enhancement Eligibility Verification (EEV) Update

John Spears discussed a handout (Attachment 1.) He indicated that the goal of IMRP is to improve the eligibility integrity of the Medicaid program and to confirm, on an annual basis, that clients who qualify for medical benefits receive them, while those who are not qualified are disenrolled.

Mr. Spears indicated that statistical information for monthly and quarterly reports about the IMRP project can be found at: <u>http://www2.illinois.gov/hfs/MedicalCustomers/eev/Pages/default.aspx</u> Luvia Quiñones, from ICIRR, expressed concern about cases that had been canceled, allegedly due to miscalculations. John Spears responded that, if it is suspected that mistakes have occurred, a client should contact his/her case worker immediately. He remarked that, per federal law, a case can be reinstated within the first three months of cancelation if the appropriate information is provided, which makes the client eligible for medical coverage without there being a gap in coverage. However, after the first day of the fourth month, clients will have to reapply for medical coverage.

### 6. Care Coordination Update

Amy Harris-Roberts made a presentation update on the managed care expansion. She reported that about 1.5 million individuals have been enrolled in managed care organizations, either through choice or as a result of having been auto-assigned. She noted that about 70,000 individuals who were enrolled in the Cook County Waiver are receiving enrollment packets from the Client Enrollment Broker (CEB) to inform them about their options with respect to selecting a managed care organization. Participants will have two months to make a selection.

Ms. Harris-Roberts indicated that the Department has identified two health plans which were sanctioned during this enrollment process. As part of the quality control measures, the Department

identified some quality concerns, resulting in these health plans being temporarily withdrawn. The letters sent to entities involved can be found in the HFS website under the "Care Coordination" tab. Upon addressing the deficiencies and meeting the requirements stipulated by their contracts, both health plans were once again reinstated. Ms. Harris-Roberts responded to various questions about the CEB assisting clients to find alternative medical providers. In addition, the committee requested more details about the "Managed Care and Patients' Rights Act," concerning the 90-day transition of care information included in the MCO and MCCN contracts. This information, it was stated, would be made available to the committee members through an e-mail upon conclusion of the meeting.

### 7. Open Discussion and Announcements

Kathy Chan announced that Ramon Gardenhire, Health Advocate from the Aids Foundation of Chicago (AFC), is a new member of the committee.

The committee approved the originally proposed meeting date of December 10th to be changed to December 3<sup>rd</sup>, 2015, in order to avoid a schedule conflict. Erin Weir made a motion that the change should be adopted which was seconded by Brittany Ward. The vote was taken with nine being in favor of the motion and none opposed. Chairperson, Kathy Chan announced that she will not be attending April 9<sup>th</sup> meeting, and John Jansa volunteered to chair the meeting.

John Jansa expressed concerned about clients with limited English skills. He suggested that the Department should provide data regarding how many people indicated Spanish or "other" as their "language of choice." In the absence of Ramon Gardenhire, Kathy Chan expressed his request for data regarding enrollment by population category (kids, pregnant women, parents and relative caregivers, SPDs, etc.) Jacqui Ellinger indicated that the department publishes enrollment information on its website. She also indicated that the department will explore the possibility of conducting a webinar or tutorial so that interested parties can access this information. 
