Public Comment Notice - Home and Community Based Services Waiver

7/19/2021

The Illinois Department of Healthcare and Family Services (HFS) proposes to amend the Adults with Developmental Disabilities waiver – IL 0350. Changes proposed in the amendment are as follows:

- Modify service definitions and rate methodologies for:
 - o Residential Habilitation
 - Community Day Services
 - Supported Employment
 - Individual Employment Supports
 - Group Employment Supports
- Add a new waiver service and rate methodology titled Virtual Day Services
- Increasing the service limit for all day programs combined from 1,100 hours annually to 1,200 hours annually
- Establishing a service limit for Supported Employment Individual Employment Supports of 300 hours annually which counts toward the 1,200 hour annual limit for all day programs combined.

Illinois seeks public input on this proposed amendment to the Adults with Developmental Disabilities waiver through two separate statements of public notice.
