### Table 1

**CPT:** Any code listed in this column follows the panel pricing logic

**Panel Count:** Number of components counted for this code

**Component of Panel:** "X" indicates code is also part of a panel; if submitted separately from that panel on the same day of service that a panel is billed, the code will be rejected.

**Rate:** global rate for the panel if submitted without other procedure codes.

**Rate after 2.7% reduction:** rate paid to provider types whose rates were reduced under the SMART Act effective for dates of service on or after 07/01/12.

### Table 2

**# of Tests:** Total when Panel count from Table 1 is added. When a combination of codes from the CPT column is submitted, the totals from the Count column are added. That count goes to the Panel Allowable table to price. Whichever code processes first prices at full; subsequent codes are priced at reduced rates until the maximum panel rate has been paid, then all other codes pay at \$0.

**Global:** Amount payable when both professional and technical components are performed and submitted by the same provider

**26/TC:** Amount payable when only the professional (26) or technical (TC) component is performed and submitted by the provider

**Global after 2.7% reduction:** Amount payable when both professional and technical components are performed and submitted by the same provider, after reduction applied to provider types whose rates were reduced under the SMART Act effective for dates of service on or after 07/01/12.

**26/TC:** Amount payable when only the professional or technical component is performed and submitted by the provider, after reduction applied to provider types whose rates were reduced under the SMART Act effective for dates of service on or after 07/01/12.

### Examples:

Single code from Table 1 submitted for date of service after 07/01/12, billed by independent laboratory:

80053 = 14, pays at \$10.36, minus 2.7% = \$10.08 for independent laboratory.

Multiple codes from Table 1 submitted for date of service after 07/01/12, billed by practitioner:

$(80053) + (80061) = (14 \text{ tests}) + (3 \text{ tests}) = 17 \text{ tests}$

Panel allowable for 17 tests by practitioner = \$10.43

- If 80053 processes first, it pays \$10.36. That leaves \$.07 payable for 80061.
- If 80061 processes first, it pays 6.22. That leaves \$4.21 payable for 80053.
