Calculation of FFY 2021 Hospice Care Rates

0651 (Routine Home Care Days 1-60)	\$137.08	\$62.43
0651 (Routine Home Care Days 61+)	\$108.35	\$49.34
055X or 056X (Service Intensity Add-On)	\$41.02	\$18.69
0652 (Continuous Home Care)	\$984.59	\$448.38
0655 (Inpatient Respite Care)	\$262.72	\$222.64
0656 (General Inpatient Care)	\$669.33	\$376.33

The payment amounts for routine home care, inpatient respite care, and general inpatient care are calculated as follows:

The CBSA Wage Index multiplied by the Wage Component equals the Base Rate.

The Base Rate plus the Non-weighted Amount equals the Daily Rate.

The payment amount for service intensity add-on is calculated as follows:

The CBSA Wage Index multiplied by the Wage Component equals the Base Rate.

The Base Rate plus the Non-weighted Amount equals the Hourly Rate.

The Hourly Rate divided by four equals the Quarter-Hour Rate.

The payment amount for continuous home care is calculated as follows:

The CBSA Wage Index multiplied by the Wage Component equals the Base Rate.

The Base Rate plus the Non-weighted Amount equals the Daily Rate.

The Daily Rate divided by 96 quarter-hour units equals the Quarter-Hour Rate.

The Base Rate of \$126.88 plus the Non-weighted Amount of \$62.43 equals the Daily Rate of \$189.31.	The Base Rate of \$100.29 plus the Non-weighted Amount of \$49.34 equals the Daily Rate of \$149.63.

Service Intensity Add-On (055X or 056X)	Continuous Home Care (0652)
CBSA Code 44100 has an associated Wage Index of 0.9256.	CBSA Code 44100 has an associated Wage Index of 0.9256.
0.9256 multiplied by the Wage Component of \$41.02 equals the Base Rate of \$37.97.	0.9256 multiplied by the Wage Component of \$984.59 equals the Base Rate of \$911.34.
The Base Rate of \$37.97 plus the Non-weighted Amount of \$18.69 equals the Hourly Rate of \$56.66.	The Base Rate of \$911.34 plus the Non-weighted Amount of \$448.38 equals the Daily Rate of \$1,359.72.
The Hourly Rate of \$56.66 divided by four equals \$14.16 per Quarter-Hour unit.	The Daily Rate of \$1,359.72 divided by 96 Quarter-Hour units in a day equals \$14.16 per Quarter-Hour unit.

0.9256 multiplied by the Wage Component of \$262.72 equals a Base Rate of \$243.17.	0.9256 multiplied by the Wage Component of \$669.33 equals the Base Rate of \$619.53.
The Base Rate of \$243.17 plus the Non-weighted Amount of \$222.64 equals the Daily Rate of \$465.81.	The Base Rate of \$619.53 plus the Non-weighted Amount of \$376.33 equals the Daily Rate of \$995.86.
