Public Comment Notice - Home and Community Based Services Waiver

9/30/19

The Illinois Department of Healthcare and Family Services (HFS), in conjunction with the Illinois Department of Human Services (DHS), propose to amend the following Home and Community Based Services (HCBS) Waiver:

Persons with Disabilities - IL 0142

The amendment is necessary to seek federal approval of several service rate increases included in the State's Fiscal Year 2020 budget. Rates will be increased for the following services: Emergency Home Response Service Installation (EHRS), Adult Day Service (ADS) and Adult Day Service Transportation (ADST), and In-Home Services.

Illinois seeks public input on this proposed Waiver Amendment to the HCBS Waiver for Persons with Disabilities through two separate statements of public notice and input.
