0651 (Routine Home Care Days 1-60)	\$152.55	\$78.58
0651 (Routine Home Care Days 61+)	\$120.24	\$61.94
055X or 056X (Service Intensity Add-On)	\$52.48	\$17.31
0652 (Continuous Home Care)	\$1,259.56	\$415.38
0655 (Inpatient Respite Care)	\$341.91	\$218.60
0656 (General Inpatient Care)	\$761.91	\$437.95

The payment amounts for routine home care, inpatient respite care, and general inpatient care are calculated as follows:

The CBSA Wage Index multiplied by the Wage Component equals the Base Rate.

The Base Rate plus the Non-weighted Amount equals the Daily Rate.

The payment amount for service intensity add-on is calculated as follows:

The CBSA Wage Index multiplied by the Wage Component equals the Base Rate.

The Base Rate plus the Non-weighted Amount equals the Hourly Rate.

The Hourly Rate divided by four equals the Quarter-Hour Rate.

The payment amount for continuous home care is calculated as follows:

The CBSA Wage Index multiplied by the Wage Component equals the Base Rate.

The Base Rate plus the Non-weighted Amount equals the Daily Rate.

The Daily Rate divided by 96 quarter-hour units equals the Quarter-Hour Rate.

0.9599 multiplied by the Wage Component of \$52.48 equals the Base Rate of \$50.38.	0.9599 multiplied by the Wage Component of \$1,259.56. equals the Base Rate of \$1209.05
The Base Rate of \$50.38 plus the Non-weighted Amount of \$17.31 equals the Hourly Rate of \$67.69.	The Base Rate of \$1,209.05 plus the Non-weighted Amount of \$415.38 equals the Daily Rate of \$1,624.43.
The Hourly Rate of \$67.69 divided by four equals \$16.92 per Quarter-Hour unit.	The Daily Rate of \$1,624.43 divided by 96 Quarter-Hour units in a day equals \$16.92 per Quarter-Hour unit.

0.9599 multiplied by the Wage Component of \$341.91 equals a Base Rate of \$328.20.	0.9599 multiplied by the Wage Component of \$761.91 equals the Base Rate of \$731.36.
The Base Rate of \$328.20 plus the Non-weighted Amount of \$218.60 equals the Daily Rate of \$546.80.	The Base Rate of \$731.36 plus the Non-weighted Amount of \$437.95 equals the Daily Rate of \$1,169.31.
