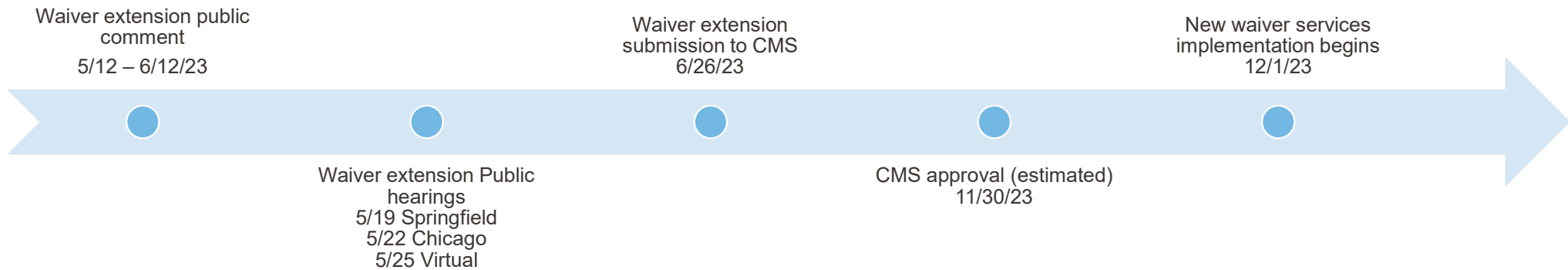
Presentation: Behavioral Health Transformation Section 1115 Waiver Extension



Background

- Illinois received approval for its 1115 Behavioral Health Transformation Waiver in 2018; expires June 30, 2023
- HFS is submitting request to extend and significantly amend to address **Health Related Social Needs**
 - Seeking to advance equity through policy, managed care, quality management
- Proposing to rename the demonstration “**Illinois Healthcare Transformation Section 1115 Demonstration**”

Healthcare Transformation Waiver Timeline



NOTE:

- Current 1115 initially approved in 2018
- Year 5 concludes June 30, 2023
- Requesting extension and amendment of services in existing authority

1115 Transformation Waiver - Proposal

HFS' 1115 request seeks authorization for two closely related efforts:

- Adding new **services** targeting HRSN, and
- Sustaining certain existing **pilots** and adding new demonstration pilots to test the value of new services and flexibilities in targeted ways
