- Registrants will be provided with details of how to join the meeting to provide comments by **no later than 5:00 p.m. on Thursday, May 11, 2023.**

Regarding the Submission of Written Comments:

- Additionally, interested parties may also provide written comments to the Department in lieu of speaking during the meeting.
- Comments will be read into to record by the Chair or administrative personnel.
