**RE:** Aetna Better Health Premier Plan MMAI - Sanction and Corrective Action Plan for Failure to Comply with Provider Network Reporting Requirements

Dear Mr. Smith:

This letter serves as written notification to Aetna Better Health MMAI of sanction pursuant to Section 5.3.14.1.11 of the Medicare-Medicaid Alignment Initiative (MMAI) Contract for failing to comply with reporting requirements. The details for each provider network reporting requirement failure, and sanction value are provided below:
