• CSAC Quarterly Numbers – Pam Lowry

Support Order Establishment is slightly up. Current Collections Percent is also slightly up. Arrears Debt Percent is down slightly. This may be due to a delay in tax refunds. Caseload is something that we look at month to month. It was mentioned that there has been a decrease in the number of teenage girls having babies. The majority of parents in our caseload are now part of the millennial generation, who may be less likely to make parenting and support arrangement formally through the courts

• Income Shares – Proposed final draft of Gross to Net Conversion and Income Shares Schedule Based on Net Income – Bryan Tribble

The table for conversion of gross to standardized net income and the Basic Child Support Obligation schedule were distributed at the meeting and will be posted with the CSAC materials on the HFS website. The draft report is also published on the HFS web site. HFS will publish a child support estimator tool on the HFS website on July 1. This tool will calculate an estimated child support obligation using the income shares guidelines statutory requirements and will link to the Basic Support Obligation schedule. For IV-D cases, legal representatives for the Department will utilize an application that has been developed specifically for their use. HFS is currently engaged in application testing and expects an on-time delivery. The next quadrennial guidelines review is scheduled for 2018.

New Business – Committee Members

Committee member asked how administrative and judicial cases will be handled with income shares Department staff indicated that administrative establishment of support and/or modification of support on administrative orders will utilize the application developed for IV-D cases.
