Dear Ms. Wolhart:

This letter serves as written notification to Blue Cross Blue Shield of Illinois ("BCBS") of sanction pursuant to Section 7.16.17 of the Contract for Furnishing Health Services by a Managed Care Organization between the Department of Healthcare and Family Services ("Department") and BCBS. Pursuant to 89 Ill. Adm. Code 140.75, within 30 calendar days after receiving a disputed claim from the Department's provider complaint portal, the MCO will develop a written proposal to resolve the disputed claims, which shall be electronically transmitted to the provider and uploaded to the provider complaint portal.

BCBS is in direct violation of 89 III. Adm. Code 140.75 by not providing a written response/resolution within the 30 calendar day timeframe for the following ticket:
