MAC Meeting Minutes:

Feb 4, 2022

- **L** Call to Order: The meeting was called to order by Ann Lundy, Madam Chair on Friday, February 4, 2022 at 10:02 a.m. on the WebEx Platform.
- II. Roll Call of Committee Members: Melishia Bansa, Special Assistant to Director of HFS, facilitated Roll Call of Committee Members
- III. Introduction of HFS Staff: Melishia Bansa, Special Assistant to Director of HFS, introduced Theresa Eagleson, Director of HFS. Presenters from the HFS Executive team were asked to make introductions during their presentations in the order they were listed on the agenda. She summarized updates to nursing home rate improvements. The MAC was encouraged to share recommendations for future topics that could benefit the Medicaid population and help HFS innovate and improve the Medicaid Program. Director Eagleson referenced several newly implemented innovative highlights such as: provisions for home monitoring equipment for pregnant women in partnership with Managed Care partners, working with providers across the state in the Behavioral Space to the roll out a new assessment and care planning tool called the IM+CANS Provider Portal, and Nursing Home Rate Improvements.

Motion: Amber Smock, proposed that the MAC recommend to HFS that disability and access data be included in the ADT records. This motion was moved forward by Ann Lundy, Madam Chair. This motion was seconded by Cheryl Whitaker with a recommendation to amend the motion to include they look into the capabilities of the tool and vendor selected to capture disability data on a person or a member seeking care in the Medicaid program. Amendment to motion moved forward by Ann Lundy, Madam Chair. No oppositions. No abstentions. Motion Carried.
