### What is Pathways to Success?

A program for children with complex behavioral health challenges that provides access to home and community-based services.


Built upon an intensive model of care coordination that addresses the broad range of each child and family's needs.

Guided by System of Care principles that put children and families at the center of planning for services and supports.

Designed to address many of the State's commitments under the N.B. Consent Decree.

Begins serving children and families January 1, 2023.

### FAMILY DRIVEN DEFINITION

"Family driven means families have a primary decision-making role in the care of their own children as well as the policies and procedures governing care for all children in their community, state, tribe, territory and nation..."



# What is Family Peer Support?

- A structured, strengths-based, individualized service provided to a parent, legal guardian or primary caregiver of a Pathways enrolled youth.
- Designed to enhance the caregiver's capacity to:
  - Understand the youth's behavioral health needs;
  - Support the youth in the home and community; and,
  - Advocate for services and supports for the youth and family.
- Delivered by Family Peer Supporters who have individual lived experience or experience as a caregiver or a child with special needs, preferably behavioral health needs.

# Why Family Peer Support?

- Family peer supporters are trained on how to engage with families who may be reluctant to take advantage of beneficial services.
- Disrupts the status quo by validating expertise based on lived experience rather than educational credentials.
- Works to break down some of the decades long barriers between communities and social service systems. These barriers were built on distrust due to historic marginalization.
- Offers personal support to parents/caregivers through crises.

### Family Peer Supporters:

Embrace the importance of shared experience Make personal connections to their peer's story Share their story for the purpose of healing peers in the community (schools, courts, medical centers, Support etc.)

### Roles and Responsibilities

#### Assist the family with:

- Engaging in support services
- Self-advocacy and self-efficacy
- Systems navigation
- Information about the child's behavioral health needs and strengths
- Building natural supports





Family Peer Supporters promote effective family driven practice!





#### **FPS Activities**

Include but are not limited to:

- Assisting the family to engage in services and supports;
- Assisting the family in self advocacy;
- Assisting in systems navigation;
- Providing information about the child's needs and strengths;
- Identification and building of natural supports; and
- Promoting effective family-driven practice.

FPS services are delivered by video, phone or face-to-face contact.

### Family Peer Supporter Qualifications



Minimally a Rehabilitative Services Associate (RSA).



Lived experience or experience as a caregiver of a child with special needs.



Experience navigating child-serving systems and supporting, educating and advocating for families involved with child-serving systems.



Access to supervision provided by a QMHP who actively participates in ongoing training and coaching specific to FPS.



Complete PATH's Family Peer Support training process and actively participate in ongoing training and coaching.

### FPS Training Requirements

- Family Peer Supporters must complete the following training through PATH:
  - Take the self-paced Systems of Care in Illinois course\*;
  - Attend the 2-day Your Bridge to Family Peer Support core training\*;
  - Attend the 2-day Care Coordination core training within 6 months; and,
  - Participate in required advanced courses and ongoing quarterly boosters.
- FPS Supervisors must complete the System of Care in Illinois course and attend a 1-day course specific to supervision and coaching of FPS.
  - FPS Supervisors are highly recommended to attend all the Family Peer Supporter required trainings to better support their staff.



#### **FPS Role Considerations**

- FPS providers are dependent upon referrals from CCSO staff for Pathways eligible youth. Strong relationships with CCSOs are essential for consistent and effective use of FPS.
- CCSO Care Coordinators should discuss the benefits of FPS services with Pathways families early and often.
  - FPS is the only planned service that should be offered and referred before the Child and Family Team has its first meeting.
- Depending upon credential of FPS staff, other services may be provided in addition to the FPS service; however, FPS should not provide other Pathways or Medicaid services for the same family that they are providing FPS for.

### Provider Enrollment and Billing





#### **IMPACT** Provider Enrollment

- Providers must be enrolled in IMPACT to deliver Family Peer Support services.
- The site enrolling must be certified as a CMHC or BHC.
- Enrollment for all Pathways services is open now providers can submit an application or modification in IMPACT at any time.
