Illinois Healthcare Transformation 1115 Waiver Annual Public Forum

To provide an update on progress of Illinois' Healthcare Transformation 1115 Waiver and to solicit comments.

The Illinois Department of Healthcare and Family Services will hold a virtual public forum on the state's Healthcare Transformation 1115 Medicaid waiver. The Centers for Medicare and Medicaid Services requires the Illinois Medicaid Program to hold an annual public forum to solicit comments on the progress of the state's 1115 Demonstration Waivers.
