\*Please refer to the August 12, 2019 provider notice regarding changes to vaccination billing requirements. Effective September 1, 2019 the Department requires that providers administer vaccines obtained through the VFC Program to all children enrolled in HFS' medical programs, including Title XXI (Children's Health Insurance Program, or CHIP) and state-only funded children ages 0 through 18. Effective September 1, 2019, providers will no longer be reimbursed for the cost of privately purchased vaccines for CHIP and state-only funded children if the vaccine is available through the VFC program. The Department will reimburse practitioners, local health departments, and school-based linked health centers \$6.40 for the administrative cost of acquiring the free vaccine through the VFC program for all children covered through the Department's medical programs regardless of title eligibility. FQHCs, RHCs and ERCs do not receive the additional \$6.40 for the administrative cost of acquiring the vaccine.

\*\*Please refer to the October 17, 2019 <u>provider notice</u> regarding phase-out of paper claim billing. Effective with claims received on and after November 1, 2019, the Department will no longer accept paper claims that do not require an attachment for processing.
