Public Comment Notice - Home and Community Based Services Waiver

## 6/17/2021

The Illinois Department of Healthcare and Family Services (HFS) proposes to renew the Persons with who are Elderly waiver – IL 0143. The renewal contains few changes from the current waiver. The primary differences are:

- Changing the effective date of the waiver from 11/1/2021 to 10/1/2021 to align with the Federal fiscal year.
- Update the waiver capacities and overall cost estimates to reflect historical trends for both feefor-service and Managed Care Organization (MCO) customers.
- Update eligibility by adding the eligibility group for the TWWIIA group (working disabled).
   Illinois' Health Benefits for Workers with Disabilities program allows customers through age 64 to participate in this program.
- Update Appendix D to increase the face-to-face contacts from once a year to every six months for fee-for-service participants.
- Update Appendix F, Fair Hearings section, to align with MCO contract requirements and to reflect the Intergovernmental Agreement with the Department on Aging.
- Update Appendix G, Response to Critical Incidents section, to describe the State's new Critical
  Event Reporting Application system. This system captures critical incidents that are not related
  to abuse, neglect, self-neglect, or exploitation. Additionally, the Response to Critical Incidents
  Section was rewritten so that the language flows better and is easier to understand the different
  reporting and tracking systems.
- Update performance measures reflecting CMS recommendations, specifically in Appendix G, and included two new performance measures specific to the Settings rule.

Illinois seeks public input on this proposed waiver renewal of the HCBS Waiver for Persons who are Elderly through two separate statements of public notice.
