Public Comment Notice - Home and Community Based Services Waiver

02/01/2021

The Illinois Department of Healthcare and Family Services (HFS) proposes to amend the following Home and Community Based Services (HCBS) Waiver:

• HCBS Waiver for Persons with Disabilities – IL 0142

The purpose of this amendment is to correct errors in J-2-d and to request an increase in the Homemaker (in-home service) rate from \$21.84 to \$23.40, effective April 1, 2021. The rate increase is in response to legislation passed by the Illinois General Assembly (GA) in SB264. The implementation of the rate increase was delayed from January 1 to April 1 in response to budget reductions announced by Governor Pritzker on December 15, 2020.

Illinois seeks public input on this proposed Waiver Amendment to the HCBS Waiver for Persons with Disabilities through two separate statements of public notice and input.
