SEIU Healthcare Illinois is a union comprised of 90,000 care workers including thousands of hospital workers in Chicagoland and an advocate for hospital workers and patients across our state.

We are writing today to express support for the new Tiered Safety-Net Add-On which will provide an additional \$50 million a year to Illinois hospitals that care for a disproportionate number of Medicaid patients.

Safety-net hospitals are embedded in vulnerable communities where big, affluent health systems like Advocate Health and Northwestern Medicine are mostly absent.

They face significant financial challenges due to the high percentage of Medicaid beneficiaries in their patient population which, as our members who work in safety-net hospitals know all too well, can affect the quality and quantity of care provided.

SEIU Healthcare Illinois is particularly pleased with the tiered structure of the new add-on that provides more financial support to the facilities in the greatest need.

Our only criticism of the new policy is that it allows grandfathered safety-net hospitals that no longer meet the necessary criteria and safety-net hospitals that are part of large, affluent health systems to receive add-on payments.



These facilities are either no longer in financial distress and/or can draw on the significant big system resources to offset losses from serving a significant percentage of Medicaid patients.

They neither need nor deserve additional support.

Despite this criticism, SEIU Healthcare Illinois broadly supports the new Tiered Safety-Net Add-On as a smart and equitable policy mechanism to provide much needed additional financial support to our state's essential safety-net hospitals.
