

Integrated Care Program Update

August 10, 2011

General information

- The two finalized ICP contracts with Aetna Better Health and IlliniCare Health Plan were signed April 28, 2011 and are available online at <http://www.hfs.illinois.gov/managedcare/>

Enrollment Material

- The department began mailing enrollment packets during March 2011, and the first enrollees to receive health care benefits through the program began May 1, 2011.
- At the end of July 2011, **34,507** enrollees had received ICP enrollment material. These enrollees reside in suburban Cook, DuPage, Kane, Will, Kankakee and Lake Counties.
- **3,455** residents of Long Term Care facilities are now receiving onsite enrollment assistance through the department's client enrollment broker (Automated Health Systems). Over the next couple of months, AHS will bring enrollment material to the LTC facilities to provide educational sessions followed up with enrollment assistance.
- The department is collaborating with DHS, the State-Operated Developmental Centers (SODCs) and the Intermediate Care Facilities for the Developmentally Disabled (ICFDDs) in developing and sending a letter to guardians so they fully understand their responsibility in the enrollment process.

Enrollment Data

- As of August 10, 2011, **28,039** people have enrolled in ICP.
- **13,982** members (50%) have joined Aetna Better Health
- **14,057** members (50%) have joined IlliniCare Health Plan
- The begin date of coverage for these enrollees varies, depending on the date the members enrolled.
