# I. Welcome and Call to Order / Introductions

The meeting was opened, and roll call was taken. A quorum was established.

## II. Approval of Meeting Minutes

Because the October meeting was canceled due to technical issues, the minutes from the September meeting were approved.

## III. Healthcare & Family Services Implementation Update

Chairperson Crider asked Kristine to provide an update on the implementation of the Pathways to Success program, and Kristine provided the following update:

• IMPACT is now open for CCSOs to complete the enrollment process, and 13 of the 22 approved CCSOs have submitted their enrollments. HFS has also identified CCSOs for DSA 10 and 7. Still looking for coverage for the Rock Island area and LaSalle, Kendal and Grundy county areas.

- IMPACT is also open for providers who want to offer other Pathways to Success services including Intensive Home-Based, Family Peer Support, Therapeutic Mentoring and Respite. HFS conducted another webinar to overview the other Pathways services on Nov 10th had over 150 participants and will be hosting additional webinars specific to Intensive Home Based on Nov 16th and Family Peer Support on Nov 17<sup>th</sup>. The provider notice for these webinars was posted on Nov 4<sup>th</sup>.
- HFS is also finalizing the ARPA Grant Agreements that CCSOs will need to sign so that HFS can
  begin disbursement of ARPA funds to CCSOs to support implementation and to establish
  Individual and Therapeutic Support Services funds. Grant agreements have been sent to all of
  the CCSOs and are moving through the process of finalization.
- HFS continues to host CCSO Office Hours at 2:00pm each Thursday, and they continue to be well attended and productive.
- Training has begun for care coordination staff and supervisors. We have had 9 staff and 6 supervisors participate so far. Trainings for additional services are also open. So far we have had three participants in the Therapeutic Mentoring training. It has been a slow ramp up so far, but we are anticipating that as CCSOs continue hiring and other providers begin to show interest in the process that those numbers will increase.
- HFS has completed the readiness reviews for MCR and has received responses to the Readiness Review Tool for Care Coordination and Support. HFS will be reviewing those responses and working with CCSOs to address any deficiencies through November and December, including conducting an on-site review at each CCSO.
- In December, HFS will receive final staffing lists from CCSOs to determine how many children they will be able to begin serving in January. HFS will assign children to each of the CCSOs and will notify MCOs of the assignments.
- In January, CCSOs will begin engaging Pathways youth and families and will also begin providing services for youth in the Family Support Program. Anticipating 5 youth per High Fidelity care coordinator and 8 youth per Intensive Care Coordination care coordinator.
- The timeline is really subject to CCSO readiness. If a CCSO is able to staff up more quickly and
  ready to provide services more quickly, HFS will accommodate that schedule. If CCSOs are not
  ready to go by January, HFs will accommodate that as well. We want to get services in the
  community as quickly as possible but are fully cognizant of the current challenges that providers
  are experiencing.
- The Decision Support Criteria to determine eligibility has been approved. HFS has done a first run of the data and has sent the numbers to the CCSOs for planning purposes only at this point. The DSC will be posted in the next two weeks.
- CCSO handbook has been posted (just a reminder).
- The Pathways to Success Administrative Rule 141 was on JCARs August calendar and was approved for adoption
- The Implementation Plan and Milestone document will be updated with new timelines based on the approval date of the 1915(i).
- The CCSO Handbook is going through final approval and will be posted soon.

Q: The contact amendment from one of the MCOs mentioned participating in the Joint Pathways Oversight Committee. What is that?

A: The JOC is a joint committee between HFS and the MCOs for the oversight of CCSOs. As a CCSO, you agree to be bound by all decisions made by the JOC, including reporting or sanctions. However, CCSOs do not have to participate in that meeting.

Q: For the staffing reports, will that be discussed during a meeting or will it be sent in? The LPHA/Clinical manager is a challenge.

A: Each CCSO will send in a staffing report. We understand that the clinical / LPHA staff may be a challenge, so we will just need to know from each CCSO what their staffing looks like in December to be able to determine who is ready for a January rollout.

Q: For the on-site visits, will there be multiple visits from both HFS and the MCOs? A: It will only be one visit by either the MCO or HFS.

Q: Who is responsible for processing requests for individual support services and therapeutic support services?

A: We will give more details about that process in the very near future.

Q: For the Behavioral Health Decisions Support Model, do you want this group to provide feedback before it is posted?

A: HFS conducted a clinical workgroup during which we received really detailed feedback from clinicians. Now we are looking at overview of how the Model works. We will be sure this group gets that once we have it ready to publicly post. Will ask to make sure we have it clear and ask for feedback. Will have ready in next 2 weeks for review and posting.

Q: Are youth with autism able to receive Pathways to Success services?

A: Youth who meet all of the eligibility requirements will be able to receive Pathways to Success services. While the services under Pathways to Success are not designed to serve youth with severe developmental disabilities, they and their families will be able to receive care coordination and any other Pathways to Success services that the Child and Family Team determine will be beneficial.

### IV. Subcommittee Feedback on Provider and Family Engagement Strategies

Chairperson Crider provided an update from the Family Workgroup:

The Family Workgroup created a document for the purpose of assisting families who need to navigate systems to discover services that fit their needs. Members of the group are responsible for contributing information to complete document that is currently in draft form. Each member in attendance shared their information and provided an update. Jennifer, Anna, and Regina all provided updates. Jennifer will send more information to Regina this week to complete section.

The DRAFT document was shared for discussion and is attached to the meeting minutes.

Chairperson Crider asked for an update from the Provider Messaging Workgroup:

Update was provided by Stephanie Barisch, who indicated that the four phases of the communication strategy has been completed. The Provider Messaging Workgroup is reviewing the work product that the Family Communications Workgroup developed. Now need to focus on getting information out to the public, posted on HFS' website and communicated to providers.
